

NOTES REGARDING AMENDMENTS TO THE SCHEDULES
TO THE CUSTOMS AND EXCISE ACT, 1964

8 APRIL 2011

These notes are issued merely as a guide and both the old and new provisions should be studied in order to determine what the amendment actually entails. These notes have no legal status.

Provision	Note
	The effect of this amendment is that the –
2933.49.10	General, EU and EFTA rates of duty on compounds of polymerised 1, 2-dihydro-2, 2, 4-trimethyl- quinoline are reduced respectively from 10%, 1,3% and 5% to free;
5902.10	General and EFTA rates of duty on tyre cord fabric of high tenacity yarn of nylon or other polyamides are reduced respectively from 15% and 9% to free;
5902.20	General, EU and EFTA rates of duty on tyre cord fabric of high tenacity yarn of polyesters are reduced respectively from 15%, 9% and 9% to free;
5902.90	General, EU and EFTA rates of duty on tyre cord fabric of high tenacity yarn of other polyamides, polycsters or viscose rayon are reduced respectively from 15%, 9% and 9% to free; and
5906.10.15	General, EU and EFTA rates of duty on woven fabrics of polyvinyl alcohol of a width of 30 mm or more but not exceeding 60 mm and of a mass of 60 g/m ² or more but not exceeding 130 g/m ² are reduced respectively from 22%, 10% and 10% to free.
