1. This Bid follows the general procurement notice for this project that appeared in issue No. WB 1101-1102/13 of Business Development from February 28, 2013.

2. Argentina has received from the International Bank for Reconstruction and Development a loan to partially finance the cost of the Project for Essential Functions and Public Health Programs (HSPA II) and intends to apply part of the proceeds of this loan to make payments under the contract for Drug FESP II 1st line TB LPI-1065-B.

3. The International Financing Unit of Health invites eligible bidders to submit sealed bids for Provision of 1st line drugs for Tuberculosis (TB) for all lots or single lot or completely full set of items as detailed below:

4. Qualifications requirements include: (a) Average annual income: The Bidder shall provide documentary evidence to demonstrate compliance with the following financial criteria: The volume of annual average sales turnover of the last 3 years must be equivalent to at least 6 times the value of the offer. (b) Experience and Technical Capacity: The Bidder shall furnish documentary evidence to demonstrate compliance with the following experience requirements: i) Installed capacity of production: The bidder or the manufacturer in the event that the bidder is not the manufacturer, it should have a minimum of installed capacity on average annual production. ii) Number of similar contracts executed: The bidder must have executed in full at least 3 similar contracts that are the subject of this tender

during the last five (5) years. It means similar to that which has the property subject as offered in amounts at least equal to the contract amount offered. iii) Experience: The Bidder must demonstrate that they have manufactured and/or marketed the specific goods offered for a period not less than two (2) years and similar goods for at least five (5) years. It is defined as specific goods, the same products in composition and form requested for each lot and for similar goods in general medicine.

5. Bidders will be evaluated by the entire lot or combination of complete lots, awarding the contract to the lowest price, according to the supplier's ability to provide the goods successfully. Further details are provided in the Bidding Documents. A margin of preference shall be given to goods manufactured in the Purchaser's country

6. The tender is made under ICB procedure indicated in the publication of the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, and is open to all bidders from eligible source countries as specified in such standards.

7. The document will be shipped upon verification of payment, by air mail or by electronic means, for shipment overseas and land or sea mail, or special mail service or by electronic means, for shipments within the country or delivered to the address listed at the end of this paper (2).

9. Bids must be delivered to the address indicated at the end of this document **no later than 12:00 pm on December 29, 2014**. All bids must be accompanied by a Declaration of Maintenance Offer.

10. Bids received after the deadline will be rejected. The bid opening will take place in the presence of bidders' and/or representatives who choose to attend at the address listed at the end of the document at 12 pm. of December 29, 2014.
