



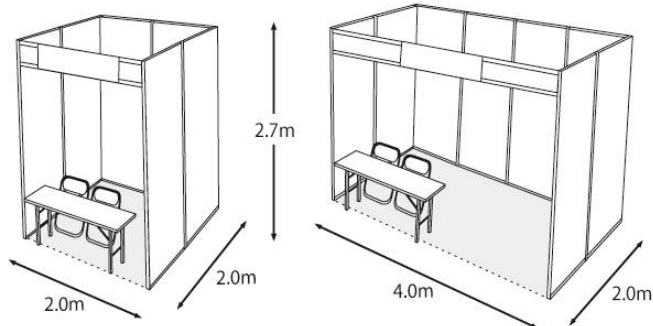

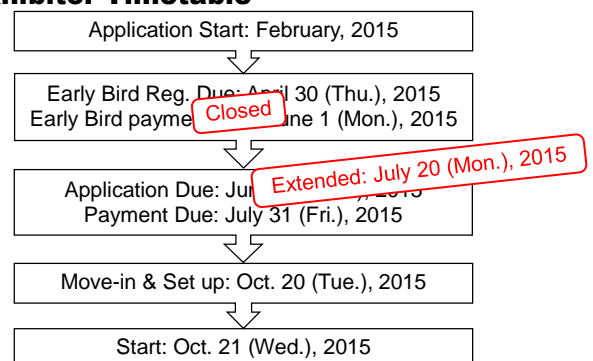
Payment method: Payment shall be made by cash remittance in Japanese yen, and the bank transfer charge is to be paid by the Applicant.

- 4) Any goods that require a naked flame (except those for which the prior permission of local fire authorities has been obtained).
- 5) Goods for which the prior consent of the Organizer has not been obtained.
- 6) Goods under special instruction or advisory by local authorities.
- 7) Goods likely to conflict with laws, ordinances or public morals.
- 8) Goods for which false or misleading claims are made regarding their country of origin or geographical indication.
