6.	<b>Description of content:</b> This Malaysian Protocol for the Halal Meat and Poultry Productions prescribes practical guidelines for abattoir/slaughterhouse on slaughtering, stunning method, further dressing process, storage and transportation of halal meat, poultry and their products. It shall be used together with the Malaysian Standard MS 1500:2009, Halal food - Production, preparation, handling and storage - General guidelines (Second revision).  This protocol was developed to give clear guidance in the production of halal meat, poultry and their products. It will apply to all establishments producing halal meat, poultry and their products including those intending to export to Malaysia. This protocol serves as a supplement requirement for MS 1500:2009.
