Letter on adjustment of the format of Chinese inspection and quarantine certificate

Turkish Embassy,

The General Administration of Quality Supervision, Inspection and Quarantine of the People's Republic of China on April 20 of this year started the upgrade of the business management informationization system. After the system has been upgraded, the format of the inspection and quarantine certificate issued by the entry-exit inspection and quarantine authorities of all provinces and cities of China will be changed as follows:

1. The serial number of certificate will be changed to 18 digits. The rule of serial number is as follows: the first digit represents the code of business types, the second to third digits represent year, and the fourth to the eighteenth digits represent the serial number.
2. The certificate can be printed in two ways. The first way is to use blank paper special for certificate to print the content of certificate and the format of certificate. The second way is to use the paper special for certificate with the format of certificate to print the content of certificate.

The upgrading of the system will last for a period, and therefore, the certificates of the new format and the old format will probably exist at the same time before the completion of upgrading of the system.

The Turkish Embassy is kindly requested to assist in informing the competent authorities of Turkey of the above-mentioned.

关于中国检验检疫证书格式调整的通知

王傅胜驻伊大使鉴：

中国国家质检总局(AQSIQ)于今年4月20日启动了国家检验检疫证书系统升级工作。系统升级后，各地出入境检验检疫机构(CIQ)签发的检验检疫证书格式将发生以下变化：

一、证书编号变为18位，编号规则为：第1位为证书类型代码，第2至3位为年份，第4至18位为顺序号。

二、证书可通过两种方式打印：一是使用空白的证书专用纸，将打印证书内容和证书格式；二是使用印有证书格式的证书专用纸，仅打印证书内容。

由于系统升级工作将持续一段时间，因此在系统升级完成前，新旧格式的证书将可能同时存在。
