

## 2016/2017 GSP Annual Product Review: 2016 Import Statistics Relating to Competitive Need Limitations (CNLs), De Minimis Waivers, and Product Redesignations

This document contains the lists referred to in a forthcoming notice published in the Federal Register entitled “2016/2017 Generalized System of Preferences (GSP) Annual Product Review: Inviting Public Comments on Possible Actions Related to Competitive Need Limitations.”

These lists are provided for informational purposes only. Interested parties are strongly encouraged to independently research the 2016 trade statistics, using the U.S. International Trade Commission’s (USITC) “dataweb” site, which can be found at <https://dataweb.usitc.gov/>

**List I** shows GSP-eligible articles from beneficiary developing countries (BDCs) that exceeded a CNL by having been imported into the United States in 2016 in excess of \$175 million, or in a quantity equal to or greater than 50 percent of the total U.S. import value for this product in 2016. These products will be removed from eligibility for GSP for the subject countries on July 1, 2017, unless the President grants a waiver for the product for the subject country in response to a petition filed by an interested party. Such petitions for CNL waivers must have been previously submitted in the 2016/2017 GSP Annual Review. (See 80 FR 50376 and 80 FR 71913.) The last column in List I shows the product for which a petition has been accepted and is now under review.

**List II** identifies GSP-eligible articles from BDCs that are above the 50 percent CNL, but that are eligible for a de minimis waiver of the 50 percent CNL. Articles eligible for de minimis waivers are automatically considered in the GSP annual review process, without the filing of a petition. Public comments (including comments in support of or in opposition to de minimis waivers) are invited in accordance with the requirements for submissions set out in the referenced Federal Register notice.

**List III** shows GSP-eligible articles from certain BDCs that are currently not receiving GSP duty-free treatment, but that may be considered for GSP redesignation based on 2016 trade data and consideration of certain statutory factors. Recommendations to the President on redesignations are normally made as part of the GSP annual review process, and public comments (including comments in support of or in opposition to redesignations) are invited in accordance with the requirements for submissions set out in the referenced Federal Register notice.

No existing CNL waivers were found to be eligible for revocation based on 2016 trade statistics, so there is no List IV.
