

On 23 December 2016 Governmental Resolution N 567 – regarding border control of food/feed of non-animal origin was adopted. The resolution entered into force from 1st December 2017. According of this resolution In case of import of food and feed from certain third countries (Annex N 3 of Resolution N567) due to contamination risk by aflatoxins, each consignment shall be accompanied by the results of sampling and analysis performed by the competent authorities of the country of origin or of the country where the consignment is consigned from If that country is different from the country of origin. Each consignment shall also be accompanied by a health certificate in accordance with the model set out in Annex N 6 of Resolution N567.

Each consignment of food and feed shall be identified with an identification code (consignment code) which corresponds to the identification code on the results of the sampling and analysis and the health certificate referred to Annex N 6 of Resolution N567. Each individual bag, or other packaging form, of the consignment shall be identified with that identification code.

Where a consignment of feed and food is not accompanied by the results of sampling and analysis and the health certificate or where the results of sampling and analysis or the health certificate do not comply with the provisions of this resolution the consignment may not enter Georgia and must be re-dispatched to the country of origin
