1. This Invitation for Tenders follows the General Procurement Notice (GPN) for this Project which appeared in Daily Newspaper, Issue No. 12,401 dated 31st May, 2019.
2. Tanzania Petroleum Development Corporation (TPDC) has set aside funds for its operations during the financial year 2019/20. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the Acquisition and Processing of 3D Seismic Data in 4/1B and Mnazi Bay North Blocks located in offshore Tanzania.
3. TPDC now invites sealed tenders from eligible registered contractors for carrying out the Acquisition and Processing of 3D Seismic Data as follows:
 - i. Acquire and process 93.1 sq.km of 3D seismic data in Mnazi Bay North Block, and
 - ii. Acquire and process 600 sq.km of 3D seismic data in Block 4/1B.
4. Tendering will be conducted through the International Competitive Tendering method specified in the Public Procurement Regulations, Government Notice No. 446 of 2013 and is open to all Tenderers as defined in the Regulations unless otherwise stated in the Tender Data Sheet.
5. Interested eligible tenderers may obtain further information from and inspect the Tendering Documents at the office of the Secretary of the Tender Board located at TPDC head office, Benjamin William Mkapa Pension Towers, Tower "A" Jamhuri/Azi Kiwe Streets, Dar-es-Salaam, Tanzania, room number 101, 10th floor from 9.00 to 15.00 hours on Mondays to Fridays inclusive except on public holidays.

A complete set of Tendering Document(s) in English language and additional sets may be purchased by interested tenderers on the submission of a written application to the address given below and upon payment of a non-refundable fee of USD 50 (United States Dollars fifty only) or equivalent amount in Tanzania Shillings using Bank of Tanzania (BOT) applicable exchange rate on the tender purchase date. 7. All Tenders must be accompanied by a tender security in an acceptable form in the amount of 2.5 percent of the tender amount or freely convertible currencies in case of foreign tenderers.
