## REQUEST FOR EXPRESSION OF INTEREST NO. AE/016/2019-20/HQ/C/05.

**Feasibility Study, Preliminary Engineering Design, Detailed Engineering Design and Preparation of Tender Documents For Development of New Coastal, Cruise Ship and Container Terminals (Berths 12-15) at Dar Es Salaam Port.**

### INTERNATIONAL COMPETITIVE SELECTION

Tanzania Ports Authority (TPA) intends to procure a Consultant to provide the aforementioned consultancy services for development of the said port infrastructure with the goal of increasing the capacity of the Dar es Salaam port to handle containerized cargoes and promote cruise ship industry in the country.

The objective of the consultancy services is to conduct a feasibility study, preliminary engineering designs, detailed engineering design and preparation of tender documents for development of the **new coastal marine vessels terminal, cruise ships terminal and a container terminal** at Dar es Salaam port. To achieve this, the consultant shall provide a detailed assessment of technical, economic, financial, commercial, legal, social and environmental viability for developing the three (3) proposed terminals. The assignment is divided into two phases, namely; phase one (1) - Feasibility Study and Preliminary Design and phase two (2) - Detailed Engineering Designs and Preparation of Tender Documents, subject to approval by TPA of the most optimal option. At the end of Phase one, there will be a "break point" and a period during which TPA and other stakeholders will review the results and recommendations from Phase one. A decision will then be taken whether to proceed with Phase two or not and only upon approval by TPA the consultant shall proceed with Phase two.

TPA now invites expressions of interest (EOIs) from eligible and qualified Consulting firms (Consultants) to indicate their interest in providing the services. Interested consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the services. The short-listing criteria are:

- (a) The firm's general experience in the last 10 years.
- (b) The firm's experience in undertaking similar assignments related to ports or marine structures.
- (c) Availability of the qualified staff to be engaged in the assignment.

- (d) Provide at least two contracts done by the firm with minimum 200,000 USD in the last 5 years.

Consultants may associate with other firms in the form of a Joint Venture or a Sub-Consultancy to enhance their qualifications. International Consultants must associate with local Tanzanian firms (at a minimum of 20% contribution of the local firm) for targeted transfer of the expertise to Tanzania firms.

Consultant will be selected in accordance with the procedures set out in the Public Procurement Act No. 7 of 2011 and its Regulations of 2013.

Prospective firms are therefore required to register themselves and access this invitation through TANEPS, via [www.ppra.go.tz](http://www.ppra.go.tz). After confirming their registrations they will be required to request and pay for registrations fee by clicking Supplier management then choose the method of payment.
