Title, number of pages and language(s) of the notified document:</b> Draft Commission Delegated Regulation amending Delegated Regulation (EU) 2022/2104 supplementing Regulation (EU) No 1308/2013 of the European Parliament and of the Council as regards marketing standards for olive oil; (4 page(s), in English), (16 page(s), in English)</p>
<p><b>6. Description of content:</b> Limit values for the characteristics of olive oil set out in Regulation (EU) 2022/2104 are set in accordance with the IOC Trade Standard applying to olive oil and olive-pomace oil (IOC Trade Standard). The IOC Trade Standard changed with regard to one chemical parameter, Δ-7-stigmastenol, and Delegated Regulation (EU) 2022/2104 should be amended accordingly.</p>
<p><b>7. Objective and rationale, including the nature of urgent problems where applicable:</b> The purpose of this act is to align Commission Delegated Regulation (EU) 2022/2104 of 29 July 2022 with IOC Trade standard with regard to one chemical parameter, Δ-7-stigmastenol; Reducing trade barriers and facilitating trade</p>
