The Ministry of Economy presents its highest consideration to the Embassy of the Republic of Turkey in Ukraine and, in response to the letter dated 13.02.2026 No. 7, has the honor to inform you about the registration of the Ministry of Trade of the Republic of Turkey as an interested party within the framework of the anti-dumping investigation into the import into Ukraine of **irrigation equipment and devices** originating in the Republic of Türkiye, the United Arab Emirates, Saudi Arabia and the People's Republic of China (*hereinafter referred to as the investigation*), initiated in accordance with the decision of the Interdepartmental Commission on International Trade dated 26.01.2026 No. AD-594/2026/441-01.

In accordance with the Law of Ukraine “On Protection of National Producers from Dumping Imports”, we are sending a non-confidential version of the complaint of the Limited Liability Company “VARIANT AGRO BUD” and the Limited Liability Company “IPRIS – PROFILE” on the initiation and conduct of an anti-dumping investigation into the import into Ukraine of irrigation equipment and devices originating from the Republic of Türkiye, the United Arab Emirates, Saudi Arabia and the People's Republic of China, which is available on the cloud storage (Google Drive) in the folder “1\_Complaint” “ADR\_irrigation 2026” at the link: <https://surli.cc/eznger>
