

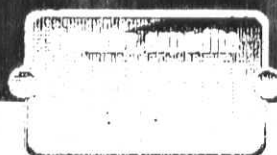
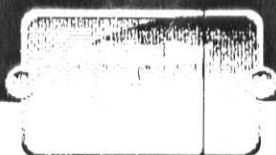


# "INDIA-CENTRAL EUROPE BUSINESS FORUM"



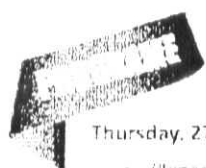
